**UK PRIZE COMPETITION TERMS AND CONDITIONS**

## 1. The Promoter

The promoter is: ExamWorks UK Limited of Premex House Futura Park, Horwich, Bolton, BL6 6SX ("**Promoter**").

"**Promoter**" means, in relation to ExamWorks UK Limited, that company, any subsidiary or holding company of that company or any holding company of any such holding company and any subsidiary of any holding company (as referred to herein) from time to time (for this purpose the expressions "subsidiary" and "holding company" shall have the meanings set out in S1159 Companies Act 2006);

## 2. The competition

2.1 The title of the competition is PremeXmas – Tis the Season To Be Gif'ing ("**Competition**").

2.2 The Competition will be run on social media platforms Twitter and LinkedIn. In order to submit a valid entry, an entrant must submit an answer to what is behind each advent calendar door by retweeting or sharing our posts and including their answer. Additional entries into the draw will be given for tagging colleagues on Twitter &/or LinkedIn, providing their answer is correct. For the avoidance of doubt if the entrant does not tag in a colleague on one of the applicable social media platforms but their answer is correct, the entrants name will only be entered into the Competition once. There is no limit on the limit of entries.

## 3. How to enter

3.1 The Competition will run from 1<sup>st</sup> December 2020 (the "**Opening Date**") to 22<sup>nd</sup> December 2020 (the "**Closing Date**") inclusive.

3.2 Each draw will take place at the end of each working week, with the winner being announced the following Monday.

3.3 To enter the Competition:

- (a) to enter the Competition entrants must do so on social media and in accordance with condition 2.2 above.

3.4 No purchase necessary and there is no charge to register for use of the website. The Promoter will **not** accept:

- (a) responsibility for Competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any postal

failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or

(b) proof of posting or transmission as proof of receipt of entry to the Competition.

3.5 By submitting a Competition entry, you are agreeing to be bound by these terms and conditions.

3.8 The Competition entries will be chosen using a random online entry picker. This will not be publicised or shown live online.

#### **4. Eligibility**

4.1 In entering the Competition, you confirm that you are eligible to do so and eligible to claim any prize you may win. The Promoter may require you to provide proof that you are eligible to enter the Competition.

4.2 The Promoter will not accept Competition entries that are:

- (a) automatically generated by computer;
- (b) completed by third parties or in bulk;
- (c) illegible, have been altered, reconstructed, forged or tampered with;
- (d) photocopies and not originals; or
- (e) incomplete.

4.3 The Promoter reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize Competition.

4.4 Competition entries cannot be returned.

#### **5. The prize**

5.1 There are 16 x £500 donations to a UK Registered Charity of the winner's choice. A UK Registered Charity can win more than once if selected by separate winners.

5.2 The prize is not negotiable or transferable.

5.3 In order to claim the prize you must confirm your chosen UK Registered Charity by no later than 7 days after the Competition closes.

## **6. Winner announcement**

6.1 Each challenge winner of the Competition will be announced before midnight, the working day after each challenge week closes on @PremexGroup Twitter feed and LinkedIn feed (**Announcement Date**).

6.2 The decision of the Promoter is final and no correspondence or discussion will be entered into.

6.3 The Promoter will contact the winner personally as soon as practicable after the Announcement Date. The Promoter will not amend any contact information once the Competition entry form has been submitted.

## **7. Claiming the prize**

7.1 The prize will be sent by BACs payment or credit card payment to the winning UK Registered Charities no later than 31<sup>st</sup> January 2021.

7.2 The prize may not be claimed by a third party on your behalf.

7.3 The Promoter will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available, or has not claimed their prize within 7 of days of the Announcement Date, the Promoter reserves the right to offer the prize to the next eligible entrant selected from the correct entries that were received before the Closing Date.

7.4 The Promoter does not accept any responsibility if you are not able to take up the prize.

## **8. Limitation of liability**

Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.

## **9. Ownership of competition entries and intellectual property rights**

9.1 The Promoter does not claim any rights of ownership in your Competition entry.

11.2 The Promoter reserves the right to hold, void, suspend, cancel, or amend the prize Competition where it becomes necessary to do so.

11.3 These terms and conditions shall be governed by English law, and the parties submit to the non-exclusive jurisdiction of the courts of England and Wales.
